METHAMPHETAMINE CONTAMINATION

Methamphetamine manufacture and use can contaminate houses and cause health risks to people (particularly children) living in these houses.

There has been a lot of discussion following the release of the Standard NZS8510:2017 -Testing and decontamination of methamphetamine contaminated properties) and the Gluckman report - Methamphetamine contamination in residential properties in

New Zealand: Exposures, risk levels and interpretation of standards.

If you are unsure as to what an acceptable level is please seek advice from your advisors, your local authority (i.e. your local Council) or your Insurance Provider.

Precise Consulting recommend Methamphetamine Testing of your property:

- > If there is a suspicion that the property may have been contaminated
- > If buying or selling a property
- > At the beginning and end of tenancy in rental properties.
- > When moving into a rented property if there is a suspicion that the property may have been contaminated by previous tenant/s

TESTING FOR METHAMPHETAMINE

Assessments are conducted by competent and experienced testers in accordance with the PCL Standard Operating Procedures and methodology described in NZS8510:2017, including NIOSH 9111 method for sample collection.

The New Zealand Standard NZS8510:2017 states that a detailed assessment shall be carried out by an accredited sampler. Precise Consulting is an IANZ accredited body who hold accreditation for surface swabbing for methamphetamine in accordance with NIOSH 9111.

The Precise Consulting sampling process is IANZ accredited - accreditation held at the Wellington branch with KTPs (Key Technical People) located nationally.

Laboratory analysis is undertaken by Analytica Laboratories Analysis in accordance with NIOSH 9111 (modified).

A report is submitted to the client with recommendations based on the findings at the site. The recommendations are based on NZS 8510:2017 and other relevant Guidelines/Standards.

<p>Screening Assessment <i>An assessment to determine the presence or absence of methamphetamine in a property</i></p>	<p>Discrete sampling is conducted by individually swabbing up to ten* high recovery surfaces from high-use areas in the dwelling in accordance with NIOSH Method 9111 .</p> <p>At the laboratory, an equal portion from each sample is extracted to form one composite sample (Laboratory Composite). The composite sample is then analysed to identify whether any methamphetamine contamination is present.</p> <p><small>* Based on a 1-3 bedroomed dwelling. For larger dwellings additional samples may be required.</small></p>
<p>Detailed Assessment <i>An assessment to determine the extent and magnitude of the methamphetamine contamination in a property</i></p>	<p>Discrete sampling is conducted in accordance with NIOSH Method 9111 by individually swabbing surfaces based on guidelines in NZS8510 and the samplers experience.</p> <p>At the laboratory samples are analysed individually and reported as an individual level for each surface sampled.</p>
<p>Post-Decontamination Assessment <i>An assessment to determine whether decontamination has been successful and that levels are acceptable</i></p>	<p>Discrete sampling is conducted in accordance with NIOSH Method 9111 by individually swabbing surfaces based on guidelines in NZS8510.</p> <p>At the laboratory samples are analysed individually and reported as an individual level for each surface sampled.</p>
